More Than Homes

THFC is a proud sponsor of 'More than Homes' - the UK housing sector's campaign to raise £1m for the Trussell Trust. The 'More than Homes' campaign, led by Accent Housing, launched in 2020 as a response to the increased demand for foodbanks during the pandemic and was backed by the National Housing Federation, Chartered Institute of Housing, and the Northern Housing Consortium. Now, with the cost of living crisis, the campaign becomes more important than ever. To date, £400,000 has been raised to fight hunger across the UK, and that number continues to grow. THFC has donated to the cause on two separate occasions and is donating £50 to the Trussell Trust for each person physically present at today's seminar.

The Trussell Trust

Trussell Trust exists so we can all be free from hunger. Together, Trussell Trust has more than 1,300 local food bank centres across the UK, providing practical support for people facing hardship. 


William Miller
